BREEDING SEASON

The 2012-2013 breeding season will commence on 1st September 2012 and terminate on 31st March 2013.

SERVICE FEE

Service Fee for this agreement - \$1200

This Service Fee comprises two (2) parts.

1. A non-refundable booking fee of \$200 (Inc. GST) which will be applied to the service fee
2. The balance, due in full prior to dispatch of semen.

COLLECTION AND TRANSPORT FEES

The Mare Owner/Lessor is responsible for the cost of semen collection and all transport costs. All collection and transport costs are to be paid in full, along with the Service Fee, prior to any mares being bred.

Charges for collection and transport are available on request.

FREE RETURN

If the mare pertaining to this contract, and has been inseminated with the semen, does not produce a live foal that can stand and suckle, **Twins Performance Horses** agrees that the Service fee will be carried forward to the next season. **Twins Performance Horses** has the right to request a negative uterine culture certificate prior to the mare

being accepted for breeding the following season. All extra charges for collection and Transport of Semen are to be paid by the mare owner/lessor.

The term "Free Return" does not guarantee that a live foal will result by the mare being bred. This only applies in the case that the mare should:

1. Fail to conceive
2. Abort the foetus
3. The foal dies within 24 hours of birth

The Mare Owner/Lessor is then entitled to a return breeding to the same stallion, by the same mare the following year.

Twins Performance Horses must be notified in writing within 5 days and veterinary certificate must be supplied. The certificate must include that the mare was properly cared for and attended at foaling.

If the mare pertaining to this contract is unable to be bred, the Mare Owner/Lessor may seek consent from **Twins Performance Horses** to substitute a second mare for breeding. Additional documentation will be required to be completed and an additional booking fee of \$200 will be required, as well as payment of all collection and transportation costs of semen.

If the nominated mare changes ownership before the birth of a live foal, **Twins Performance Horses** must be notified in writing within 10 days of the sale for the Free Return to remain valid.

If the mare dies during pregnancy, a veterinary certificate must be provided within 10 days of the mare's death. In this case a second mare may be nominated for breeding.

Semen will not be dispatched until payment of the due Service Fee and collection/shipping fees have been received.

CONDITIONS OF SERVICE

Service Fees are non-refundable

- Mare Owners/Lessors should have their mares assessed for breeding soundness by a qualified veterinarian.
- For chilled semen, the service of an accredited artificial insemination breeding vet, listed by the Australian Equine Veterinary Association, is to be used by the mare Owner/Lessor.
- The Mare Owner/Lessor is to pay all veterinary costs.
- Twins Performance Horses has the right to refuse any mare for breeding.
- A Service Certificate will not be issued until all accounts are paid in full.
- One Service Certificate will be issued per breeding contract, for the mare described in this contract. The Service Certificate will be provided in a minimum of 42 days after insemination, once the mare has received a positive pregnancy test and all outstanding invoices have been paid by the Mare Owner/Lessor.
- Embryo Transfer: A further service fee is payable for each pregnancy in the event that more than one embryo is successfully flushed from a mare and any of the subsequent embryos conceive in the recipient mare/s. Additional Service Fees are payable upon a 45 day positive pregnancy test of the recipient mare/s.
- This contract represents the complete agreement between the two parties. No other agreements of any type are included unless expressly stated in this written contract.

As the Mare Owner/Lessor named herein I have authority to enter into this contract and have read and understand the conditions specified above and agree to them in full.
